Material: 100% cotton enriched with cleanser and cosmetic active ingredients

### **APPLICATION FIELD AND INTENDED USE**

Product to be used as an aid for facial cleansing and care, makeup removal, and skin cleaning.

The intended users of the product are:

General users and private individuals;

### **UNINTENDED USE**

No use other than those described in the "**APPLICATION FIELD AND INTENDED USE**" section is intended.

It is also absolutely prohibited:

- Use by children.
- Use by individuals with limited cognitive abilities.
- Use by individuals allergic to cotton and/or the ingredients listed on the product label.

### **PRODUCT LIMITATIONS.**

- The product can only be used once as it is disposable.

### **RESIDUAL RISKS.**

- It is absolutely forbidden to make any modifications to the product. Any damage resulting from improper modification by an unauthorized operator, relieves the manufacturer of all liability.
- Keep this document carefully, as it is necessary for the correct and safe use of the product.

### **SIDE EFFECTS**

**There are no side effects to report in the instruction manual.** However, do not apply the product to the skin when there is an open wound or irritation. In case of irritation caused by the product, stop application immediately and consult a doctor to check for cotton allergy.

### **STORAGE**

- Store the product indoors cool and dry, away from heat sources, open flames and direct sunlight.
- Store the product, before use, inside its original packaging.
- PAO ( period after opening) is mentioned on the packaging

### **USE**

- For facial cleansing and care, makeup removal, and skin cleansing.
- Before use, sanitize hands by washing them thoroughly with soap and water.
- Wet the hand with water; with the wet hand dab the wipe on the striped side; apply the wipe on the skin; leave on for a few seconds and remove makeup. Very important: do not squeeze the wipe once moistened. it. It is not necessary to rinse

### **AGE SUITABILITY FOR USE ON CHILDREN**

The product can be used on children from three years of age and up.

### **WARNINGS**

- AVOID IMPROPER USE
- DO NOT INGEST
- DO NOT USE ON INJURED SKIN OR MUCOUS MEMBRANES

### **DISPOSAL**

After use, the wipe should be disposed of in general waste.

The plastic packaging (LDPE4) can be disposed of in plastic recycling.

Check your local disposal regulations.

Do not disperse or abandon the product and packaging in the environment for any reason.
